**Application for Disaster Relief Assistance**

***Type of Assistance***

Assistance is available to qualified applicants towards one of the following options: 1) Monthly mortgage expense for the primary residence that was damaged by Illinois Disaster 2) Rental cost of temporary shelter due to displacement from the primary residence resulting from the disaster or 3) unreimbursed losses directly related to the disaster (e.g. Insurance Deductible, home-related not covered by insurance). Relief assistance is limited to a maximum of \$500 per applicant per household. Deadline for application submission is October 1, 2017. Please note this assistance is for housing relief only; other expenses including vehicle purchase, rental, repair and or mileage are ineligible for reimbursement under this program.

***Eligibility***

Recipient must be a full-time resident and U.S. citizen or legally admitted for residence in the United States. Applications will be reviewed without knowledge of the identity of the applicant.

***Confidentiality***

All information provided on this form will remain confidential and will be available only to those who need to confirm eligibility for assistance and to those who process the assistance to be provided. This includes providing a copy of this application to the applicant's lender or landlord, if requested. It will not be shared with other parties for any other purpose.

***Disbursement of Funds***

In order to provide for a reasonable and equitable distribution of funds, assistance will be provided on a first come, first serve basis. All grants are contingent upon the availability of funds. The Illinois REALTORS Relief Foundation reserves the right to accept or reject any application and, for good and sufficient reasons, to cancel any grant that it has made. The committee also reserves the right to change the application criteria at any time.

**Attachment Checklist**

***Required for All Applicants***

1. Proof of Residency [ie. driver's license or other governmental documentation evidencing residency]
2. Copy of Mortgage Statement or Mortgage Payment Coupon or Rent Statement or Lease Agreement or replacement estimate, insurance estimate (i.e. Documentation for the grant request).

***One of the Following is Required to Show Proof of Damage to your Primary Residence:***

- a. Photos of Damages
- b. Insurance Estimate
- c. Copies of Written Claims, Settlement Proceeds or Claim Status Reports
- d. Copies of Repair Estimates from Contractors
